RESOLUTION 17-05

**A RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS, FRANKLIN
TOWNSHIP FIRE DISTRICT NO. 1, SOMERSET COUNTY, NEW JERSEY,
AUTHORIZING AND AWARDING AN ADDITIONAL TWO YEAR TERM TO THE
CONTRACT WITH NETWORK BLADE, LLC FOR IT SUPPORT AND
PROFESSIONAL SERVICES**

WHEREAS, the Board of Fire Commissioners of Franklin Township Fire District No. 1, Somerset County, previously advertised through the RFP process and awarded a contract in accordance with the law for IT SUPPORT & PROFESSIONAL SERVICES TO Network Blade, LLC, via Resolution No. 14-48, adopted by the Board of Fire Commissioners at a public meeting held on November 24, 2014; and,

WHEREAS, the award of the contract was for two (2) years in accordance, and as authorized, pursuant to N.J.S.A. 40A:11-15; and,

WHEREAS, N.J.S.A. 40A:11-15 authorizes the Board of Fire Commissioners to extend the two (2) year contract with Network Blade, LLC for an additional one (1), two (2)-year term; and,


WHEREAS, the Board of Fire Commissioners have found the services performed by Network Blade, LLC, under the initial two (2) year contract to be both effective and efficient; and,

WHEREAS, the Board of Fire Commissioners are desirous of authorizing and awarding said additional two (2) year term to the contract with Network Blade, LLC for IT support services at the same monthly contract price not to exceed six hundred dollars (\$600.00) which shall include up to six (6) hours of labor each month; and


WHEREAS, funds are available for this purpose.

1. The contract for IT Support and Professional Services with Network Blade, LLC, 49 Marcy Street, Somerset, New Jersey, is hereby extended for an additional two (2) year term pursuant to N.J.S.A. 40A:11-15, and that the Chairman and District Clerk are hereby authorized and directed to execute a contract and any other necessary documents with Network Blade, LLC, for the total monthly contract price not to exceed six hundred dollars (\$600.00) which shall include up to six (6) hours of labor each month.


