***Resolution to Amend the 2009 Approved Budget***

***WHEREAS***, the Franklin Township Fire District No. 1 Budget for the Fiscal Year beginning on January 1, 2009 and ending on December 31, 2009 was introduced on the 8<sup>th</sup> day of December, 2008; and

***WHEREAS***, a public hearing on the 2009 Fire District budget has been held on January 23, 2009 as publicly advertised; and

***WHEREAS***, the budget as introduced included a proposed public referendum in the amount of \$100,641 in excess of the allowable amount to be raised by taxation; and,

***WHEREAS***, the referendum in the amount of \$100,641 in excess of the allowable amount to be raised by taxation was defeated; and

***NOW, THEREFORE BE IT RESOLVED*** by the Board of Fire Commissioners of the Franklin Township Fire District No. 1 that the following amendments to the adopted 2009 Fire District Budget be made:











